TAKE NOTICE that the appellants hereby note an appeal to this Honourable Court in respect of the judgment (other than paragraphs 188 to 200 thereof) and the order, including the order as to costs, of the Honourable Mr Justice Vahed handed down on 4 December 2023.

TAKE NOTICE FURTHER that leave to appeal to the Supreme Court of Appeal was granted by this Court (per Mokgohloa JA and Dippenaar AJA) on 25 July 2024, as appears from the order annexed, marked "A".

TAKE NOTICE FURTHER that appellants seek the following order:

- 1. The appeal is upheld with costs, including the costs of two counsel.
- 2. The order of the Court *a quo* is set aside and substituted with an order in the following terms:
 - Declaring that the third to fifth applicants ("the BRPs") are empowered to suspend, for the duration of the business rescue proceedings, any payment

obligation of the first applicant ("THL") which arises under the Sugar Industry Agreement, 2000; and

Directing the first to fourth, seventh, eighth and twelfth respondents to pay the applicants' costs, including the costs of two counsel, jointly and severally, the one paying the other to be absolved.

TAKE NOTICE FURTHER that, *in the alternative* to the order above, the appellants seek the following order:

- 1. The appeal is upheld with costs, including the costs of two counsel.
- 2. The order of the Court *a quo* is set aside and substituted with an order in the following terms:
 - Declaring section 136(2)(a)(i) of the Companies Act 71 of 2008 unconstitutional and invalid insofar as it fails to provide for the suspension of regulatory charges that become due during business rescue proceedings; and
 - Reading in the words "inter partes" before the word "obligation" and the words "or regulatory regime" after the word "agreement" in section 136(2)(a)(i) of the Companies Act.
 - 3. Directing the first to fourth, seventh, eighth and twelfth respondents to pay the applicants' costs, including the costs of two counsel, jointly and severally, the one paying the other to be absolved.
